

A. PROGRAMME OVERVIEW

1. What is the programme about? What are the objectives?
 - MyPAC ACCA Programme is established for Malaysian Accounting Degree holders who wish to pursue their professional accounting qualification at approved training service provider.
 - The said programme aims to accelerate candidates' career in accountancy and subsequently to increase the numbers Bumiputera Professional Accountants.
2. Who is this programme for?

This programme is targeted at Accounting Degree holders who are interested in obtaining the ACCA Qualification.

The requirements as follows:

 - I. Bumiputera and a Malaysian citizen
 - II. Not exceeding 25 years of age at the point of application
 - III. Obtained a minimum of 3.0 CGPA
 - IV. Completed degree in accountancy from accredited universities; AND
 - V. Obtained 9 paper exemptions from ACCA
3. Which professional accounting certification will I be able to pursue in this programme?

MyPAC ACCA Programme offers you the opportunity to obtain the ACCA Qualification.
4. What are the benefits of this programme? How is it different from others?
 - This programme gives potential scholars to obtain the ACCA Qualification while being financially supported at selected training service provider.
 - Scholars will also have the opportunity to undergo MyPAC Professional Development Programme (MPDP), a comprehensive development programme created to enhance scholars' soft skills towards becoming a well-equipped and future-ready certified professional accountants in the workforce.
5. What is the duration of the programme?

Scholars are required to complete all subjects within 2 years on a fulltime basis.
