

A. PROGRAMME OVERVIEW

1. What is the programme about? What are the objectives?
 - MyPAC Last Miler Programme (MyLM) is designed by MyPAC to provide financial assistance to eligible candidates to obtain the ACCA Qualification.
 - MyLM programme aims to accelerate candidates' career in accountancy and subsequently to increase the numbers of certified Bumiputera Professional Accountants.
2. What are the entry requirements?

The requirements as follows:

 - I. Bumiputera and a Malaysian citizen
 - II. Not exceeding 40 years of age at the point of application
 - III. Maximum of 2 papers remaining for ACCA
 - IV. Eligible for candidates who are pursuing the ACCA qualification in Malaysia
 - V. Work experience is not required
3. Which professional accounting certification will I be able to pursue in this programme?

MyPAC Professional Accountant Programme offers the candidates the opportunity to obtain the professional accounting certificate of Association of Chartered Certified Accountants (ACCA)
4. What is the duration of the programme?

The duration of the programme depends on the number of papers that scholars is left with. Typically, a scholar is given six months to complete a paper, and a buffer of another six months, in case they require it.

B. SPONSORSHIP

1. What type of sponsorship covered under this programme?
 - This is a reimbursement programme, where the scholars can claim from MyPAC each time they pass the paper.
 - The sponsorship covers annual subscription fees, examination fees, and tuition fees, but it is limited to the amount allowable by MyPAC (refer to the agreement).
 - MyPAC has the right to change any policies that have been declared hereby.
2. What are the consequences I will face if I breach the stipulated contract?
 - MyPAC reserves the right to recover all the expenditure/expenses/costs incurred during the study duration if scholars are found to breach the contract.
 - a) claim for any damages whatsoever suffered by MyPAC in connection with this Agreement in connection with any of your actions; and/or
 - b) claim any repayment from the Recipient for any money disbursed by MyPAC to the Recipient. (For the avoidance of doubt, any statement issued by MyPAC to confirm any amount related to the Reimbursement shall be deemed final and conclusive and accepted by both parties, when used pursuant to this Agreement.
 - The total amount will be calculated by MyPAC up to the point of termination.
3. Am I still eligible to receive MyPAC's sponsorship if I have received another loan/scholarship?

No. Only **ONE** sponsorship per scholar is allowed at **ONE TIME**.

C. TUITION PROVIDER

1. Am I required to attend tuition?

You are not required to attend tuition, however, if you do, we strongly suggest that you attend tuition at any of ACCA's Approved Learning Partner.

D. APPLICATION

1. How do I apply for this programme/ Where do I apply for this programme?

E. SERVICE BOND/AGREEMENT/BOND

1. Will I be bonded with MyPAC upon finishing the programme? If so, how many years the bond will be in effect?

No. Scholars who have completed this programme will not be bonded with MyPAC.

2. Am I required to commit to any kind of legal contract/agreement?

Yes. An official agreement will be prepared and issued and successful scholars are required to enter into a Sponsorship Agreement with MyPAC.

3. Will I be able to reject the offer if I am shortlisted?

Yes. The agreement is in effect after it has been signed and received by MyPAC.
